HOWEVER, IN THE EVENT ARTISTIC PRODUCTIONS FAILS TO COMPLY WITH THE TERMS OF THIS CONTRACT, LIABILITY ON THE PART OF ARTISTIC PRODUCTIONS IS LIMITED TO THE REFUND OF MONIES EQUAL TO THAT OF RESERVATION FEES AS STATED IN THIS CONTRACT. FURTHER, WE CANNOT BE HELD RESPONSIBLE OR LIABLE FOR ACTS OF GOD OR OTHER UNFORESEEABLE CIRCUMSTANCES THAT AFFECT OUR APPEARANCE OR PERFORMANCE.

ARTISTIC PRODUCTIONS WILL NOT BE HELD LIABLE FOR ANY DAMAGES OR INJURIES CAUSED BY EITHER THE EVENT SPONSOR, GUESTS OF THE EVENT, OR THIRD PARTIES. THE CLIENT NAMED ABOVE AGREES TO ASSUME ALL RESPONSIBILITY FOR ANY AND ALL PHYSICAL DAMAGE TO ARTISTIC PRODUCTIONS' EQUIPMENT CAUSED BY THE CLIENT, EVENT SPONSOR, GUESTS OF THE EVENT, AND/OR THIRD PARTIES WHILE THE EQUIPMENT IS AT THE EVENT SITE LISTED ABOVE.

RESERVATION FEES ARE NON-REFUNDABLE AND NON-TRANSFERABLE. FOR CANCELLATIONS OF THE ENGAGEMENT OR OUR SERVICES AS DESCRIBED ABOVE NINETY (90) DAYS OR LESS PRIOR TO THE DATE OF THE EVENT, CLIENT IS LIABLE FOR 50% OF THE CONTRACTUAL MONIES DUE. FOR CANCELLATIONS THIRTY (30) DAYS OR LESS PRIOR TO THE DATE OF THE EVENT, CLIENT IS LIABLE FOR 100% OF CONTRACTUAL MONIES DUE ARTISTIC PRODUCTIONS. IN THE EVENT ANY LEGAL ACTION IS NECESSARY TO ENFORCE PAYMENT OF THIS CONTRACT, THE UNDERSIGNED CLIENT AGREES TO PAY ALL COSTS OF COLLECTION, INCLUDING COURT AND ATTORNEY LEGAL FEES.

TO RESERVE OUR SERVICES, WE REQUIRE THAT A SIGNED CONTRACT BE RETURNED WITH A MINIMUM RESERVATION FEE OF \$ _____. PAYMENT OF THE BALANCE WILL BE DUE TEN (10) DAYS PRIOR TO THE EVENT DATE. OVERTIME AND ADDITIONAL SERVICES ADDED LAST MINUTE / PRIOR TO THE EVENT WILL BE DUE THE NIGHT OF THE EVENT. FOR YOUR CONVENIENCE, WE ACCEPT CASH, PERSONAL CHECK, COMPANY CHECK, VISA, MASTERCARD, AMERICAN EXPRESS AND DISCOVER CARD. A 3% CONVENIENCE FEE WILL BE CHARGED ON EACH CREDIT CARD TRANSACTION.
